Centrepay Deduction Authority form

Centrepay is a voluntary bill-paying service which is free for Centrepay Customers. You can use Centrepay to arrange regular deductions from your Centrelink payment(s).

You can use Centrepay to pay your school fees.

The quickest way to start, change, suspend or cancel a deduction at any time is through your Centrelink online account. If you cannot access your account you can use this form.

To set up or change a deduction you can:

- If I cancel the enrolment of my students at Woodcrest State College, I may also need to advise the Department of Human Services to stop my deduction.
- If I have a current Centrepay deduction and I lodge a new authority form, then the existing deduction will not carry over to the new claim.
- If my deduction has a target amount and the final deduction is set to pay less than \$2, my second last deduction will be increased by up to \$2 to cover the final amount.
